**SUBJECT: FISCAL YEAR 2010 INSTITUTIONAL FEES FOR THE UNIVERSITY OF  
CONNECTICUT, STORRS AND REGIONAL CAMPUSES**

**RECOMMENDATION:**

That the Board of Trustees approve a schedule of Institutional Fees for Fiscal Year 2010 comprised of adjustments to the following: Tuition, Room, Board, Infrastructure Maintenance Fee, Program Specific Fees (Off-Campus MBA, LLM-Insurance, LLM-U.S. Legal, MS Accounting Online, Masters Entry into Nursing), Law School Application Fee, Cooperative Bookstore Deposit and International Sponsored Student Fee.

**BACKGROUND:**

Beginning in 2002, the University embraced a new student fee review process. Three categories of fees were established: (1.) Institutional Fees, which require central administrative approval, such as Tuition, Room, Board, Infrastructure Maintenance Fee and self-supporting programs; (2.) Academic Materials Fees, which are for consumables and instructional materials that are specific to a particular course or major; and (3.) Student Fees, which include the General University Fee and student activity and service fees. Senior Management charged a permanent committee with promoting a fee structure for the academic and student fees that supports excellence, provides comprehensive procedures, and is uniform without sacrificing efficiency and flexibility.

The Institutional Fee increases have been proposed by the University leadership as the budgets for these fees are largely driven by what it takes to run the operation (including payment of debt service). Please note that the Program Specific Fees are non-mandatory fees assessed to the students enrolled in the given program

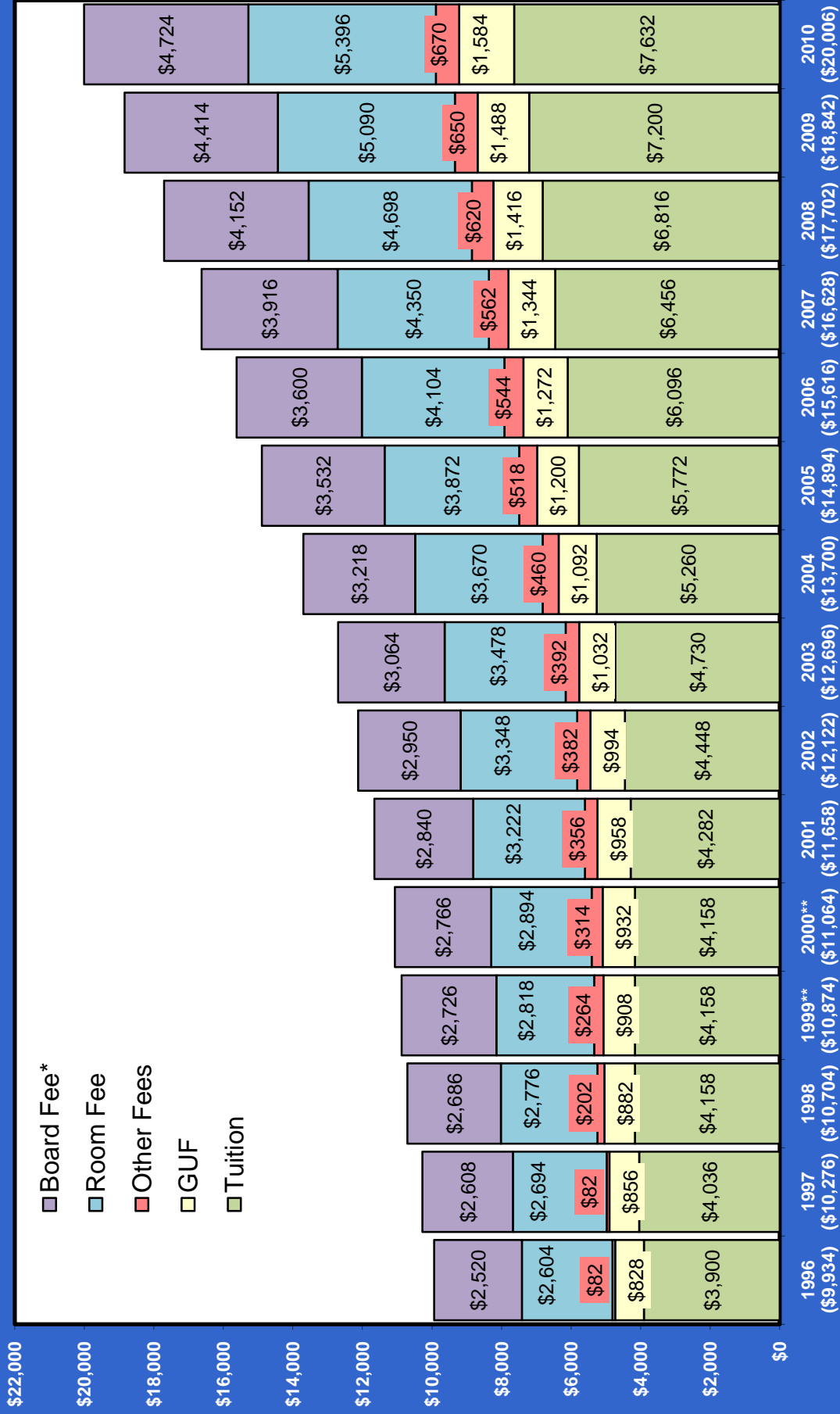

## Undergraduate In-State Cost - Fiscal Years 1996-2010

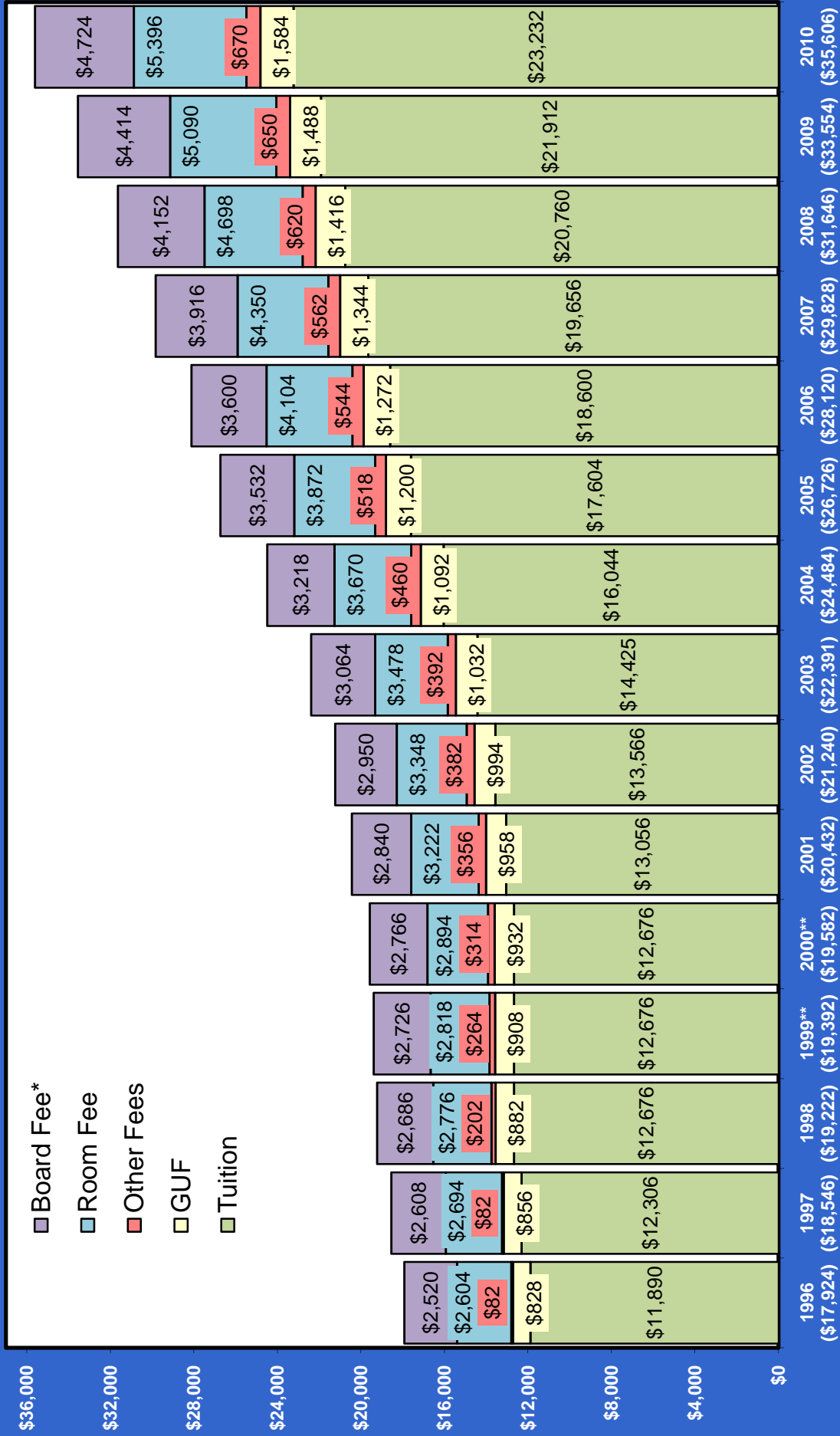

## Undergraduate Out-of-State Cost - Fiscal Years 1996-2011

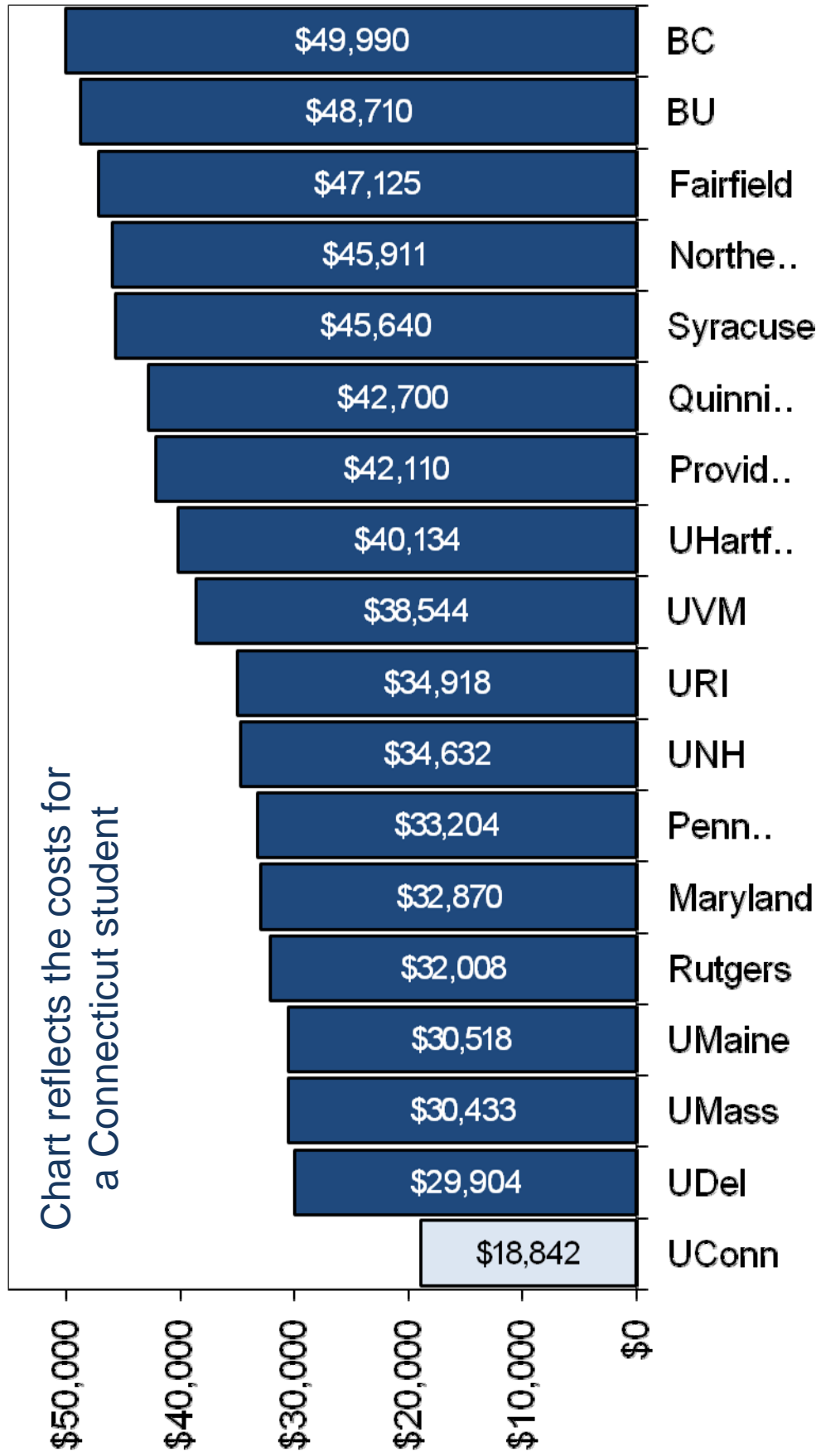

# UConn's Affordability FY 2009 Tuition, Fees, Room & Board\*

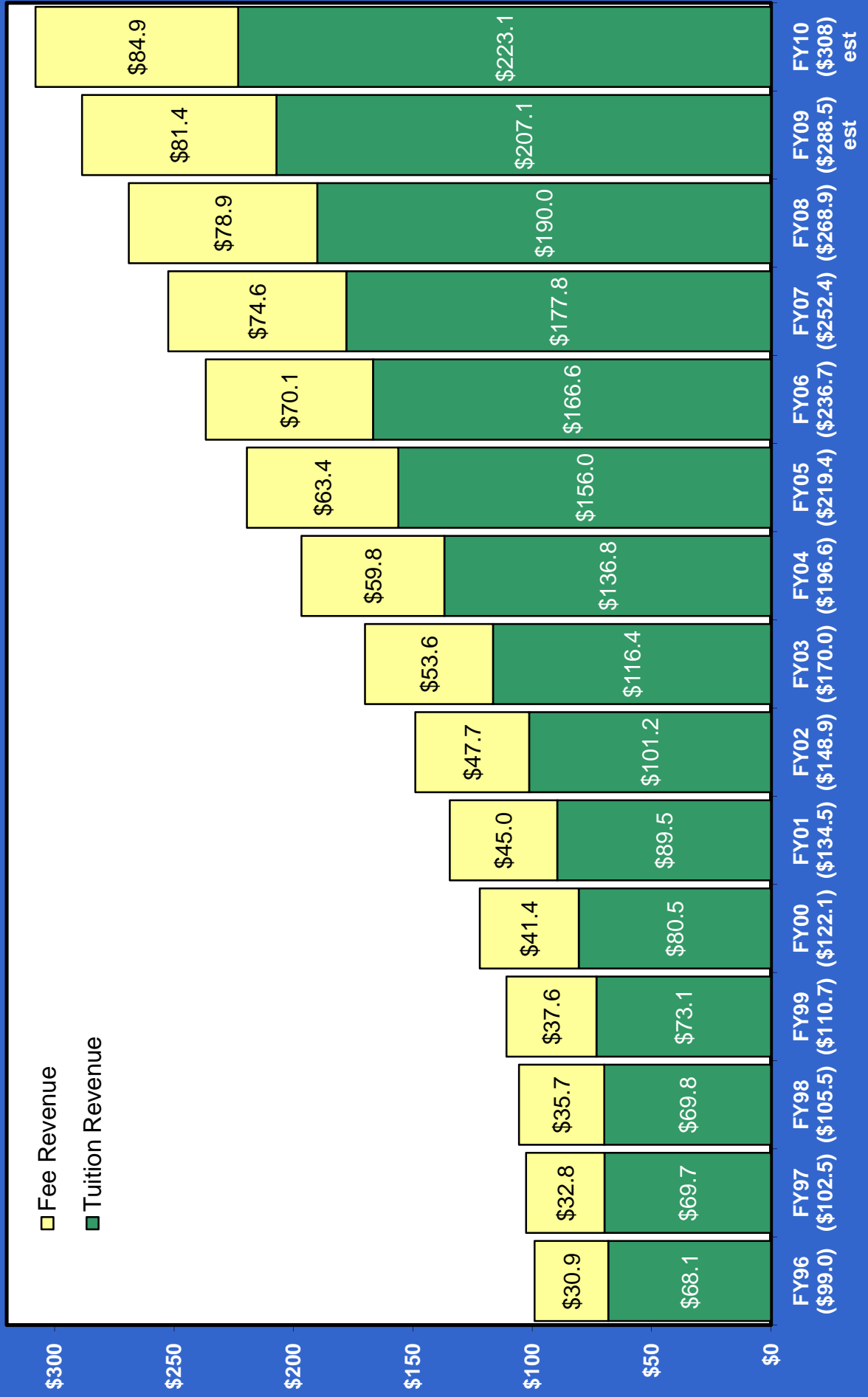

**Room Fee - Fiscal Year 2010**

**I. Proposed Action**

- A. Description of Room Fee:** 6.0% increase in FY10 on double room fee. Various increases in other room fees as noted below.
- B. Description of Recommended Revision:** In FY10, the recommended revision increases the double room fee by \$306 year/\$153 semester. Beginning in Fall 2009, the University will implement a new housing rate structure to simplify the current structure of 17 rates to 5 rates. This will create a simpler and more approachable presentation of housing alternatives for students. The new rate structure will also help the University more effectively balance the values of access and market conditions. As the new rate structure is more aligned with the various amenities offered, not all rate increases are 6.0%. Residential Life will also be increasing the occupancy of the single efficiency and 2 bedroom/2 bath apartments in Hilltop and Charter Oak apartments. This will be accomplished by converting single bedrooms into doubles. There will be a corresponding steep drop in the rate charged to students living in these facilities. These steps will enable the University to house more students and simplify the rate structure for students when choosing housing amenities.
- C. Basis of Requested Revision:** The projected fee increases are needed to meet the cost of inflation, cover utility costs, continue deferred maintenance programs, provide for equipment, purchase new furniture for the Hilltop and Charter Oak apartment conversion and routine furniture replacement.
- D. Students Affected:** The increases would apply to all students living in the University residential areas.
- E. Proposed Date of Implementation:** Fall 2009.

**II. Analysis**

- A. Fiscal Need for Revision:** The Department of Residential Life operates as a self-supporting auxiliary operation. Therefore, it is necessary for the Department to generate a sufficient amount of revenue to support its operation.
- B. Impact on Program and Clients:** Failure to implement the fee requests would result in reduction of some services to students.
- C. Comparative Student Costs:** See attached.
- D. Student Involvement in Fee Revision Proposal:** A public forum was held to present the rates as defined above.

**I. Proposed Action**

**A. Description of Board Fee:** 7.02% fee increase for FY10 as noted below.

**B. Description of Recommended Revision:**

To increase the board fee in FY10 as follows.

Ultimate

Unlimited meals, 500 points, 35 flex passes (per semester): \$310 year/\$155 semester

Value

Unlimited meals, 200 points, 40 flex passes (per semester): \$296 year/\$148 semester

Custom

Unlimited meals, 75 flex passes (per semester): \$280 year/\$140 semester

**C. Basis of Requested Revision:** The 7.02% increase in FY10 is needed to meet the cost of inflation, increases in utilities, renovations to older dining facilities, and equipment maintenance and replacement.

**D. Students Affected:** The increase would apply to all students living in the University undergraduate residence halls and any graduate or commuter student who chooses to purchase a meal plan.

**E. Proposed Date of Implementation:** Fall 2009.

**II. Analysis**

**A. Fiscal Need for Fee Revision:** The Department of Dining Services is a self-supporting auxiliary operation. Therefore, it is necessary for the Department to generate a sufficient amount of fee revenue to support its operation.

**B. Effect on Other Institutional or Unit Programs if Fee is Not Approved:**

If funding is not available for O & M costs associated with the new buildings, it may not be possible to maintain these new buildings adequately.

**C. Comparative Student Costs (Other Institutions):**

This fee is charged to all students and the revenue funds infrastructure maintenance and renovations of physical assets.

The fee is charged to all students except veterinary medicine.

University of Connecticut  
School of Business Off-Campus MBA Program Fee  
Fiscal Year 2010

**I. Proposed Action**

- A. Description of Fee:** The School of Business off-campus MBA Programs are operated as educational extension fund activities. The MBA Programs are offered off-campus at Hartford, Stamford and Waterbury as part-time evening programs. Students do not pay University tuition, as they pay a per-credit course fee for each course taken. The comprehensive per-credit course fee includes the Graduate Matriculation Fee (GMF), the Infrastructure Maintenance Fee (IMF), and a Parking Fee (Stamford only). In addition, students are charged a refundable breakage fee.
- B. Description of Recommended Revision:** The credit hour fee for the off-campus MBA Programs is currently \$590 per credit. We are requesting an increase to \$650 per credit hour effective Fall 2009. This represents an increase of 10%.
- C. Basis for Requested Fee:** Approximately seventy-nine percent of the costs incurred to deliver the MBA Program are salaries and fringe benefits. For the past several years, the cost pressures on these programs have been driven primarily by the escalating costs of mandated salary increases and the market for new faculty hires.

Since the part-time MBA program is totally dependant on enrollment driven revenues, we need to be sure there is an adequate revenue stream to cover costs and re-invest in the program.

- D. Students Affected:** Students enrolled in the off-campus MBA Programs at Hartford, Stamford, and Waterbury (approximately 1,000) will be affected. Most of these students are mid-career professionals who are employed full-time. Many students are reimbursed by their employer for their educational costs.
- E. Proposed Date of Revision Implementation:** The proposed date for implementing the fee increase from \$590 to \$650 per credit hour is Fall 2009.

**II. Analysis**

- A. Fiscal Need for Fee Revision:** As of Fall 2008 (FY09), the total comprehensive per credit fee is \$590, which includes the GMF of \$42 per semester, the IMF of \$48 per course (ranging from \$48 to \$190 depending on numbers of credits), and parking of \$20 per semester. Additionally, the programs contribute to the cost of university-wide central services.

The University of Connecticut School of Business was recently re-accredited by AACSB International (Association to Advance Collegiate Schools of Business), the hallmark of academic excellence among business schools. AACSB accreditation is a distinction earned by fewer than 15% of business schools worldwide, and one that UConn has proudly held since 1958. The UConn School of Business also ranks among the nation's top 70 business schools according to *Business Week* and *U.S. News & World Report* and is frequently referred to as the #1 public business school in New England. UConn has also been ranked

by *Forbes*, *The Wall Street Journal* and *The Princeton Review*. With respect to “America’s Best Graduate Schools” for 2009, UConn ranks 26<sup>th</sup> among the nation’s top public business schools – and 52<sup>nd</sup> overall.

The revenues generated by the off-campus MBA Programs also support critical School of Business initiatives, which are essential to maintaining and enhancing our success. The fee increases are necessary in order to maintain this momentum, as well as offset the increases in expenses in FY10.

- B. Impact Statement:** The off-campus MBA Programs are designed to be self-supporting. If the fee increase is not approved, student services and course offerings would have to be significantly modified. Further cutbacks would have a negative effect on our promotional expenditures and on the technology platform associated with delivering the curriculum. These actions could result in lower quality programs, in turn, negatively impacting future enrollments as well as revenues.

Fiscal Year 2010**

**I. Proposed Action**

**A. Description of Fee:** The history of the LL.M. Insurance Fee:

**B. Description of Recommended Revision:** For FY10, the School of Law proposes to increase the Insurance Law LL.M. Fee from \$1,009 per credit to \$1,039 per credit. This is an increase of approximately 3%.

**C. Basis of Requested Revision:** The Law School started its first LL.M. program, U.S. Legal Studies, in 1993. This program provides an opportunity for international lawyers to come to the U.S. to earn the advanced degree. In 1997, an Insurance Law LL.M. was added. Most of the students in this program are lawyers at insurance companies in the United States. With the approval of our accrediting agency, we may now deliver the program via distance learning. However, the costs of such delivery are great. This fee proposal seeks to charge the delivery fees appropriately to the Insurance LL.M. program. The American Bar Association and the University Of Connecticut Board Of Trustees approved this program with the understanding that after a period of development, the Insurance LL.M. would be financially self-supporting. The fee is still substantially below those charged by other law schools for similar programs.

**D. Students Affected:** The total LL.M. population of the School of Law is approximately 45 students. This includes full and part-time students. All Insurance Law LL.M. students would be affected by this proposal.

**E. Proposed Date of Implementation:** The proposed date of implementation would be Fall 2009.

**A. Description of Fee:** The history of the LL.M. – U.S. Legal Fee

**B. Description of Recommended Revision:** For FY10, the School of Law proposes to increase the LL.M. Fee from \$909 per credit to \$936 per credit. This is an approximate increase of 3%.

**C. Basis of Requested Revision:** Since 1993 when the U.S. Legal Studies program started, the enrollment has stabilized at approximately 12 students per year. Staff salary/fringe/worker comp and operational costs to support the program have increased during that time. The American Bar Association and the Board of Trustees approved this program with the understanding that after a period of development, the U.S. Legal LL.M. would be financially self-supporting. The fees are substantially below those charged by other law schools for similar programs.

**D. Students Affected:** The total enrollment in the U.S. Legal Studies LL.M. program is approximately twelve students. This includes full and part-time students. All U.S. Legal Studies students would be affected by this proposal.

**E. Proposed Date of Implementation:** The proposed date of implementation would be Fall 2009.

Fiscal Year 2010

**I. Proposed Action**

- A. Description of Fee:** The School of Business MS in Accounting Program is operated as an educational extension fund activity. The MS in Accounting Program is delivered on-line. Students do not pay University tuition, as they pay a per-credit course fee for each course taken. The comprehensive per-credit course fee includes the Graduate Matriculation Fee (GMF) and the Infrastructure Maintenance Fee (IMF).
- B. Description of Recommended Revision:** The current comprehensive credit hour fee for the on-line MS in Accounting Program is \$590. This rate is in effect Summer 2008, and will remain in effect through Spring 2009. We are requesting an increase to \$650 per credit hour effective Summer 2009. The summer date coincides with the beginning of a new class as this program admits students to begin coursework each May. The requested fee represents an increase of 10%.
- C. Basis for Requested Increase:** Approximately sixty-eight percent of the costs incurred to deliver the MS in Accounting Program are salary and fringe benefits. For the past several years, the cost pressure on the program has been driven primarily by the escalating costs of mandated salary increases and the market for new faculty hires.
- Since the MS in Accounting Program is totally dependant on enrollment-driven revenues, we need to be sure there is an adequate revenue stream to cover costs and re-invest in the program.
- D. Students Affected:** Students enrolled in the MS in Accounting Program (approximately 230) will be affected. Most of these students are beginning their professional careers and are employed full-time. Some students are reimbursed by their employer for their educational costs.
- E. Proposed Date of Revision Implementation:** The proposed date for implementing the fee increase from \$590 to \$650 per credit hour is the Summer 2009.

**II. Analysis**

- A. Fiscal Need for Fee Revision:** As of Summer of 2008 (FY 2009), the total comprehensive per credit fee is \$590 which includes the GMF of \$42 per student and the IMF of \$48 per course (ranging from \$48 to \$190 depending on numbers of credits). Additionally, the program contributes to the cost of university-wide central services.

The University of Connecticut School of Business and the Accounting Department was recently re-accredited by AACSB International (Association to Advance Collegiate Schools of Business), the hallmark of academic excellence among business schools. AACSB accreditation is a distinction earned by fewer than 15% of business schools worldwide, and one that UConn has proudly held since 1958. The UConn School of Business also ranks among the nation's top 70 business schools according to *Business Week* and *U.S. News & World Report* and is frequently referred to as the #1 public business school in New

Further cutbacks would have a negative effect on our promotional expenditures and on the technology platform associated with delivering the curriculum. These actions could result in lower quality programs, in turn, negatively impacting future enrollments as well as revenues.

**University of Connecticut (Storrs and Regional Campuses)**  
**School of Nursing and Center for Continuing Studies**  
**Master's Entry into Nursing (MbEIN) Program Fee**  
**Fiscal Year 2010**

**I. Proposed Action**

- A. Description of Fee:** The School of Nursing MbEIN Program is a self-supporting program for students who already have a bachelor's degree. This one year program consists of 45 credits of pre-licensure academic work which enables graduates of the program to complete the National Council Licensure Examination for Registered Nurses (NCLEX). Additionally, at the student's option, they can apply to the MS in Nursing program and transfer 9 credits toward the Masters degree. The MbEIN program has extensive delivery costs. The comprehensive program fee covers all related program costs including program administration, instruction and testing.
- B. Description of Recommended Revision:** Requesting approval to charge a MbEIN Program fee of \$22,695 for the January 2010 cohort. The fee would be adjusted for students who have previously completed some of the requirements.
- C. Basis for Requested Fee:** This 45 credit program is completed over three semesters (12 months). A new cohort begins each January and graduates in December. It is structured as a non-degree program which significantly reduces the time to complete and attain the desired RN credential. The current structure is composed of both undergraduate and graduate level courses and includes instruction, clinical work and simulated laboratory experiences.
- D. Students Affected:** The maximum number of students in this program is 96 and all students experience the same impact.
- E. Proposed Date of Implementation:** Beginning with the January 2010 cohort.

**II. Analysis**

- A. Fiscal Need for Fee Revision:** As the School of Nursing MbEIN program operates as a self-funded comprehensive activity, revenues from student fees must be sufficient to cover program costs. The MbEIN is a robust and vigorous program. To continue to thrive and grow, the expenses and quality must be balanced. The request is based on the cost of administering and delivering the program.
- B. Effect on Other Institutional or Unit Programs if Fee is Disapproved:** Without approval of the fee, the MbEIN program cannot continue. The University of Connecticut fills a critical need by championing, increasing and enhancing the State of Connecticut's Nursing workforce to meet the needs of the citizens. In addition, not offering this program would result in fewer applicants to UConn's Nursing Master's Program. This may also result in the subsequent loss of motivated students to schools in other states.
- C. Comparative Student Costs:** There are not any other programs in the Northeast designed like the MbEIN program. Three schools in the state offer a program for non-nurse college graduates, but they require the student to earn a second baccalaureate

degree. Our program was designed with the belief that a second baccalaureate degree was not needed. Southern Connecticut State University's program is 53 credits and costs \$12,766 for instate students and \$13,552 for out of state students per semester. Fairfield University's program is a minimum of 60 credits over 15 months at \$17,500 (before fees) for each of the three semesters. The cost at Saint Joseph College is \$35,860. Yale University also offers a program for the non-nurse college graduate, but their program requires the student to be at Yale for three full time academic years and earn a masters degree. The cost for the spring and fall semesters is \$14,512.50 and the summer session is \$11,375. The total cost at Yale would be \$98,450.

- D. Student Involvement in Fee Revision Proposal:** Students were apprised of the fee proposal at an open forum.

**University of Connecticut  
School of Law Student Application Fee  
Fiscal Year 2010**

**I. Proposed Action**

- A. Description of Fee:** Applicants to the Juris Doctor program at the Law School presently pay \$30 for application to either the day or evening division and \$45 for application to both divisions. The dean grants waivers of the fee based upon demonstration of significant financial hardship or other significant reasons.
- B. Description of Recommended Revision:** Effective in 2010 for the Fall 2010 incoming class, the School of Law proposes an increase in the application fee to one rate: \$60 for application to either or both the day and evening divisions.
- C. Basis of Requested Revision:** Our current fee is significantly lower than our peer schools and has created a perception that we are not a first tier Law School.
- D. Students Affected:** The total applicant pool for the Fall of 2008 was 2,010. It is anticipated that the applicant pool for the Fall of 2010 will be approximately the same.
- E. Proposed Date of Implementation:** The proposed date of implementation would be during the 2009-2010 academic year for candidates entering in the Fall of 2010.

**II. Analysis**

- A. Fiscal Need For Fee Revision:** The purpose of this proposal is not revenue driven. It is to bring our application fee more in line with our peer schools in order to maintain an applicant pool that is optimum for filling our classes.
- B. Effect on Other Institutional or Unit Programs if Fee is Disapproved:** Competition for Law School candidates is fierce and becoming more aggressive. What we have learned is that good students pay attention to the rankings and in turn are attracted to schools that are highly ranked. The quality of our students also affects our faculty recruitment ability. Hiring partners in law firms follow the rankings avidly and set up a recruiting strategy based upon highly ranked schools. It is clear that in this changing marketplace, we must become an aggressive participant in the quest for higher rankings.

**University of Connecticut (Storrs and Regional Campuses)**  
**UConn Co-op Student Cooperative Bookstore Deposit Change**  
**Fiscal Year 2010**

**I. Proposed Action**

- A. Description of Fee:** In order to belong to the UConn Co-op, matriculated undergraduate and graduate students at Storrs, the regional campuses and the Law School currently pay a one-time membership fee of \$25 called the Cooperative Bookstore Deposit,. The membership fee is returned when the student graduates or otherwise withdraws from the University. The fee appears on the matriculated student's first University of Connecticut fee bill. Professional students in the part-time MBA program and non-degree students do not pay the deposit. The Co-op deposit is collected by the University and is paid to the Co-op.
- B. Description of Recommended Revision:** Effective for the Fall 2009 semester (FY 2010), the UConn Co-op requests approval to reduce the membership fee to zero for **new** students.
- C. Basis of Requested Revision:** The UConn Co-op Board of Directors voted to lower the UConn Co-op student membership fee to \$0. Concurrent with this decision, the Board of Directors decided to make all students, at all campuses, in all programs, eligible for membership. Incoming new students will be asked if they wish to activate their membership with the Co-op. There will be no cost for activation of membership. The Co-op and the University will continue to work together to exchange student information for the next three to four years as we work through current student members from whom the membership fee was already collected. Additionally, the Co-op will need to continue to receive data from the University on all new students eligible for membership in order to offer them membership.
- D. Students Affected:** All **new** incoming matriculated undergraduate and graduate students at Storrs, the regional campuses and the Law School beginning in Fall 2009, approximately 7,300 students.
- E. Proposed Date of Implementation:** Beginning with entering students in Fall 2009.

**II. ANALYSIS**

- A. Fiscal Need For Fee Revision:** The purpose of this proposal is not revenue driven. The record-keeping involved in administering this deposit is very costly and time-consuming. The interest income that the Co-op earns on the deposit does not cover the record keeping costs.
- B. Effect on Other Institutional or Unit Programs if Fee is Disapproved:** If the reduction is not approved, the University will have to continue to provide information on students eligible for a refund (graduating students and those who have left) past the next three to four years.
- C. Comparative Student Cost:** Many co-ops and/or bookstores organized with a membership do not charge a membership fee for students. Of those who do, it varies from \$1 a year to a one-time/refundable fee of \$25.

**D. Student Involvement in Fee Revision Proposal:** The UConn Co-op is governed by an elected 15 member Board of Directors. Eight of those directors, or a voting majority, must be students according to the Bylaws. The Board voted unanimously to reduce the fee to \$0.

Although the Co-op plans to reduce the student membership fee to \$0 the Co-op expects students to remain a very significant part of its membership and there are no plans to revise the make-up of the Board of Directors. As noted, the Co-op hopes to retain a strong and active student membership in the Co-op. The Co-op believes that having students make a conscious decision about activating their membership will make students more aware of their membership and the benefits it provides.

**University of Connecticut (Storrs and Regional Campuses)**  
**International Sponsored Student Fee**  
**Fiscal Year 2010**

**I. Proposed Action**

- A. Description of Fee:** Currently the International Sponsored Student Fee of \$300 per semester is assessed to sponsored international students. Sponsored students are those international students who apply through and are funded by governmental, quasi-governmental, private and public organizations. This fee was assessed beginning in fall 1992.
- B. Description of Recommended Revision:** Eliminate the International Sponsored Student Fee.
- C. Basis of Requested Revision:** The fee creates a hardship for sponsored students as some of the sponsors have refused to pay the fee and therefore the fee is paid directly by the international students. Continuing to assess this fee may hinder our Globalization Goal in the Academic Plan, so eliminating it is timely.
- D. Students Affected:** Eliminating the fee will affect approximately ten international graduate students taking credit-bearing courses each semester. These students are sponsored by governmental, quasi-governmental, private and public organizations.
- E. Proposed Date of Implementation:** Elimination of the fee would become effective with the Fall 2009 semester.

**II. Analysis**

- A. Fiscal Need for Fee Revision:** Although the revenue generated from this fee helps fund the costs associated with international students, the amount has never exceeded \$7,000 annually.
- B. Impact on Program if Requested Fee Adjustment is Denied:** There will be no impact to the services provided to these students.
